

Standardized Dress Code for Schilling Farms Middle School (2006-07)
“Dress for Success”

ACCEPTABLE attire is set forth below. This list is not all-inclusive:

- PANTS / SHORTS
 - of appropriate size and length
 - worn at the waist
 - ***pleated or flat front; zippered or buttoned fly***
 - ***solid-colored khaki, black, or navy***
 - ***interior pockets only (no cargo pants)***
- SKIRTS / JUMPERS
 - of appropriate size and length
 - worn at the waist
 - ***khaki, navy, black, or hunter green (solid-colored or Scottish/tartan plaid)***
- SHIRTS / BLOUSES
 - of appropriate size (no tight-fitting or oversized)
 - must be tucked into clothing at all times ***so that the belt is visible***
 - ***solid, striped, or plaid, of any color***
 - ***must have both a collar (polo style, dress shirt, or turtleneck) and sleeves (long or short)***
 - ***small manufacturer’s logo acceptable (no graphic prints)***
- BELTS
 - must be worn if pants/shorts/skirts have belt loops
 - ***solid-colored, with a buckle***
- SHOES
 - ***any closed-toe style shoe (athletic, casual, or dress)***
- OUTERWEAR WORN DURING THE SCHOOL DAY
 - sweaters or lightweight jackets ***without a hood***
 - waist-length and of appropriate size
 - worn with appropriate ***collared*** shirt tucked into clothing underneath
 - ***predominantly solid, of any color***
 - ***if worn untucked, must not cover any part of the rear pants pockets***

UNACCEPTABLE attire is set forth below. This list is not all-inclusive:

- any tight, oversized, low cut, ripped, frayed, transparent, or Spandex clothing;
- ***sweatpants, pajama pants, athletic pants, or athletic shorts (except in P.E. class);***
- ***jeans of any color, except on administratively designated days;***
- shorts, skirts, dresses, or slits in dresses more than 4 inches above the knee;
- ***T-shirts, sweatshirts, or any other shirt/blouse without a collar, except on administratively designated days;***
- barebacked or bare midriff tops, shirts, or dresses;
- ***any visible undergarment, except a crew neck T-shirt worn under a collared shirt;***
- hats, hoods, or other headwear;
- ***sandals, flip flops, or other open-toe shoes;***
- sunglasses, facial tattoos, or facial jewelry (including tongue piercing);
- any profane, violent, suggestive, disruptive, illegal, or gang-related symbols or advertisements;
- unnatural hair coloring or hair carvings (mohawks, logos, etc.).

Students who for religious or health reasons are unable to comply with the above guidelines may appeal to the school principal for possible exemption.
