Memphis-Shelby County Schools is Tennessee's largest public school district and is among the 25 largest public school districts in the United States. AGE-APPROPRIATE MATERIALS ACT



(T.C.A. § 49-6-3803)

The Shelby County Board of Education urges the TN General Assembly to amend the Age-Appropriate Materials Act of 2022 to provide the local education agency or charter school the opportunity to resolve issues received from a student, parent/guardian, or a school employee regarding the appropriateness and suitability of school library collections through administrative procedures prior to requiring action by the local board of education or public charter school governing body.



MANDATORY ALTERNATIVE SCHOOL PLACEMENT

(T.C.A. § 49-6-3402)

The Shelby County Board of Education urges the TN General Assembly to provide additional discretion to a director of schools (or designee) to determine whether assignment to an alternative school or program is the appropriate placement for a student who committed an offense of violence, if such placement may endanger the safety of other students or staff at the alternative school or program.

(34 CFR Part 200 and ESSA § 8101(25))

The Shelby County Board of Education urges the Tennessee General Assembly to direct the Tennessee Advisory Commission on Intergovernmental Relations (TACIR) or other appropriate agency to (1) perform a state-wide and national study of high schools identified for support and improvement solely based on the ESSA cohort graduation rate requirement; (2) determine if high schools that graduate less than 67 percent of their students have corresponding high dropout rates attributed to issues beyond the control of the local education agency and/or school; and (3) if the high school cohort graduation requirement has a disproportionate impact among urban school districts.

CHARTER SCHOOLS



APPLICABILITY OF STATE STATUTES TO CHARTER SCHOOLS

(T.C.A.)

The Shelby County Board of Education urges the Tennessee General Assembly to clarify throughout TN Code Annotated when statutes are applicable to the local education agency and/or its schools and local board of education and a charter school and/or its governing body.

(T.C.A. § 49-2-207)

The Shelby County Board of Education urges the TN General Assembly to amend the statutory requirement for a notice of each deleted policy to be filed and made available in each school library as required currently under T.C.A. § 49-2-207.

ELECTRONIC PARTICIPATION IN BOARD MEETINGS

(T.C.A. § 49-2-203)

The Shelby County Board of Education urges the TN General Assembly to amend T.C.A. 49-2-203(c)(4) by increasing the number of times a school board member may participate electronically in a board meeting when working out of the county and/or due to family emergency.


LICENSURE REQUIREMENTS TO TEACH ELEMENTARY PHYSICAL EDUCATION COURSES



(T.C.A. § 49-6-1021)

The Shelby County Board of Education urges the Tennessee General Assembly to enact legislation to address the immediate issue of teacher shortages by granting authority to the Commissioner of Education to allow physical education courses in elementary grades to be taught by individuals under a permit.
