Welcome to the Minority, Women-Owned and Small Business Enterprise (MWSBE) Program's inaugural edition of The Business Connector Newsletter (BCN). This quarterly newsletter is to inform the community about MWSBE Program developments, introduce you to numerous decision-makers within the Shelby County Schools District, and spotlight various certified MWSBEs that will share their business testimonials.

The MWBE Program was established by Shelby County Board of Education Policy 2010. Its purpose is to promote participation of MWBEs in procurement opportunities with Shelby County Schools. To be eligible to participate in our MWBE Program, a business must have a current certification as a MBE or WBE from an approved certifying SCS agency. Some of the requirements for MBE and WBE certification include the business must be 51% owned and operated by a minority and/or woman business located in Shelby County.

We also have a Small Business Enterprise (SBE) program which is race and gender neutral program. This is a Sheltered Market program developed to increase access to contract opportunities by which small local firms will be able to compete against others that are comparably situated in the market and in their industries. To be eligible for the SBE program the business must meet the federal small business size standards and must be independently owned and operated, organized for profit, and not dominant in its field. The business owner(s) must also demonstrate that the net worth of each owner does not exceed \$1,320,000, exclusive of principal residence, and the value of the owner's interest in the certified SBE. A certification from an approved SCS certifying agency is also required.

Why participate in our MWSBE programs? We are intentional with doing business with local small businesses. We also help to facilitate business networking opportunities with prime contractors with our project goal setting initiatives on contracts over \$100,000 (non-federal). Those projects include architecture and engineering, construction, goods and supplies, non-professional services, and professional services. Our SBE program seeks to provide participants the first opportunity to bid on solicitations under \$100,000 with our sheltered market approach.

There are benefits that come with being a certified MBE, WBE, and/or SBE including your business listed in the online certified vendor directory. This list is publicly accessible, so committed business partners can identify certified MWSBEs.

As the Manager of Shelby County Schools-Department of Minority, Women-Owned and Small Business Enterprises, Joyce Douglas, along with the MWSBE team, is responsible for administering the District's MWSBE Program by providing information and assistance to certified MWSBEs.
