The closest they have is (20 x 54) I have *attached* (Exhibit A) to the table that I believe the District wants to be bid. We want to make sure the District wants the correct table top size (19" x 60") Leg style True Cantilever and Fixed Height 29"

And also, the SAND laminate that the company's table pictured does not offer as a laminate choice.
