# **Item #1** – Scope of Work Clarification:

Preventative Maintenance (Fixed Price) Invoicing. The Contractor shall submit signed service reports and invoices electronically to **EHS-FireLifeSafety@scsk12.org** upon completion of each scheduled preventive maintenance including a copy of the detailed service report for each individual system by location. Invoices submitted without the required information will not be processed for payment until the Contractor provides the required information. Emergency Repair or Non-Emergency Work Invoicing. The Contractor shall submit a signed service report with the invoices electronically to **EHS-FireLifeSafety@scsk12.org** upon completion of any service (Emergency or Non-Emergency Repair) requested by MSCS beyond the preventive maintenance schedule within 15 days of completion. All invoices shall provide detailed information including labor rate, hours charged, and description and price of any parts or supplies used to complete the emergency repair.

- 1.1 Each document supporting any invoice shall include the signature of the SBE or his/her representative.
- 2.1 Invoices submitted without the required information will not be processed for payment until the Contractor provides the required information. A proper invoice shall include, at the minimum, the following information:

The hourly rate and number of hours worked. Products(s) and/or service(s) listed separately including the deliverable number (e.g., 3.8.4.1) and the amount for each line item, unit price applied (i.e., 5 - ABC Hardware @ \$2,000 Total \$10,000.00, 2 - CD Training @ \$100.00 Total \$200.00, Installation one-time cost \$300.00)

Any adjustments or discounts made to the invoice

E-mail address/phone number of Contractor's POC

Remittance address

Federal taxpayer identification or (if owned by an individual) Contractor's social security number
