## **Questions & Answers**

1. Can you provide a quantity breakdown of each device type?

macOS – Approximately 5,000

iOS – Approximately 3,000

Windows – Approximately 110,000

2. The RFP notes under Scope of Services the District's "....usage of Apple iOS and macOS devices expands beyond niche enterprise use cases....." but does not give any indication of the approximate number of devices to be managed or the number of locations it will be deployed in.

3. Whether companies from Outside USA can apply for this? (like, from India or Canada)

Answer Oral presentation as part of the solicitation may be required as well as meetings requirements for the successful vendor. Please see response to question #5

4. Whether we need to come over there for meetings?

Answer Yes, as may be required by the solicitation and requested services.

5. Can we perform the tasks (related to RFP) outside USA? (like, from India or Canada)

Answer Please refer to Part II, Section 20.0 on Page 8 of RFP. Additionally, if the selected solution is cloud hosted, the system must be housed in the Continental U.S. Traffic must also originate from within North America (i.e. U.S. Canada, Mexico) if remote support is given.

6. Can we submit the proposals via email?

Answer No

7. The MWBE form (Appendix H) has no percentage listed for MWBE participation. Should we assume there is no required percentage for this bid? If there are no services, a non-MWBE bidder will have no workshare to offer an MWBE partner.

Answer There is a 10% goal setting for MWBE participation.

8. We would like to confirm that a bond is only required for protest purposes and that no bid bond is required with proposal submittal.

Answer No bid bond is required.

9. How many total assets does the Board of Education need to protect for their schools?

10. Does the Board of Education want Managed Services, where the bidder performs all services, or just a straight license resell?

Answer SCS Resources will manage the solution that is implemented.

11. Does the Board of Education require training for the product? If so, please provide the number of attendees, number of training sessions, and whether remote is okay or onsite is mandatory.

12. On page 28 of the RFP, it lists \$2 million general liability aggregate coverage. On Appendix G, the Certificate of Insurance Coverage form, it list a \$3 million general liability aggregate requirement. Could you confirm which amount is correct? We assume \$2 million is correct, as it is typical for services and work of this size.

Answer The Aggregate coverage for General Liability Insurance is 2 million dollars. See Addendum 1 at the link below

13. RFP, Scope of Services, para. 2., states that 2 components are required in the data center. However, we offer a cloud-based solution that is fully accredited under the Federal Government's rigorous FedRAMP Cybersecurity requirements. Would the Board accept a cloud-based solution with high security like this that would also eliminate the Board's cost for physical hardware/software and labor to manage/maintain on-premise equipment?

Answer While an on premise solution is preferred, a cloud-based solution will be considered if all requirements are met, and a TCO comparison can be shown reflecting cost savings.

21. Page 4: 2.0 Term of Agreement

Page 10: Tab D. Fiscal Integrity/Financial Statements

"The Vendor shall include in its proposal, completed audited financial statements including the auditor's notes, for its last three years. If the Vendor has not had its financial statements audited by an independent accounting firm, the Vendor must submit such un-audited financial statements as it has. Some acceptable methods include but are not limited to one or more of the following:

- a. Recently audited (or best available) financial statements
- b. Dunn and Bradstreet Rating
- c. Standard and Poor's Rating
- d. Lines of credit
- e. Evidence of a successful financial track record
- f. Evidence of adequate working capital "
