Question 1.

Can you confirm the state date and the completion date for the above referenced project?

Response

The project start date is scheduled to be April 3, 2021 and the completion date is scheduled to be July 30, 2021.

Question 2.

Can Plexitrac Accelerator be approved as an alternate?

Response

This system is a water based system and is NOT APPROVED.

Question 3.

Are there any plans for this project? I searched on the share point link provided in the documents and specifications were only posted.

Response

You can access the specifications on the link located on page 14 of the IFB. Included with the specification are photos of the location for the scope of work throughout the site.

Question 4.

Will we be submitting the bid to the address of the Shelby County Schools Department of Procurement Services?

Response

Will this project be tax exempt or not?

Response

Please refer to the language in the IFB on page 20 titled, “3.0 Prices Section E. Taxes”. SCBE does not reimburse vendor from any tax related burdens as a result of doing business with the SCBE.

Question 7.

Are there any allowances for this project?

Response

No allowances are included for this project.

Question 8.

Can Conica SP be used as an alternate for this project?

Response

Yes, this product is approved as an alternate for the Southwind HS Track Replacement project

Question 9.

Can vendors who did not attend the mandatory pre-bid meeting still submit a bid for this project?

Response

No, if your firm did not attend the mandatory pre-bid meeting, you cannot submit a bid for this project.

Question 10.

Can there be an alternate track surface added to the bid? The one spec'd in the bid package has a 12-year with maintenance life span & we would like to bid Tuflite, which has a 25 year maintenance life span?

Response

No, Turlite cannot be used as an alternate. The specification clearly call for a structural spray pervious track with 2 coats of structural spray applied to a ½" paved mat.
