## HOW TO APPROVE A REQUISITION

Personnel who need to review and approve requisitions will receive an email notification that a requisition is in your **Awaiting My Action** queue in APECS. Requisitions can be approved two ways: **Awaiting My Action (**recommended method) or through your **email** by clicking the button which enables the reviewer to log into the APECS system.

Step 1: Log into APECS and in your Awaiting My Action queue.

Step 2: Click the +box to the left of Requisitions to expand

These are the actions you can choose and enter comments to explain.

- Approve the requisition, and it will be forwarded to the next person in the approval queue.
- Approve and Insert another employee who is not already in the approval queue so he/she can review the requisition before it moves to the next person in the queue.
- **Insert** another approver to review and approve before you decide; the requisition will be returned to you after the Inserted employee reviews it.
- **Deny** a requisition has the same effect as voiding it; deny should only be used if you are positive the requisition is to be completely voided.

• **Return** requisition to the initiator for modifications; it is better to return the requisition and ask for modification than to just deny; "**Return a Requisition**", choose Return from the drop down box, must state your reason for the return and click the "Save" button. The requisition is returned to the creator for modification per your comments. Once they make the changes and click "Save and Post" the requisition will forward back to you for approval.
