Overview

At MSCS advanced coursework is comprised of Advanced Placement (AP), Pre-AP, honors, International Baccalaureate (IB), dual enrollment (DE), local dual credit (LDC), and statewide dual credit (SDC) courses.

Advanced Placement, International Baccalaureate, dual enrollment, local dual credit, and statewide dual credit courses allow students the opportunity to earn "college credit and complete introductory college classes early and prepares students for the rigors of college enabling them to adjust to college-level expectations while also having a supportive network of high school educators and peers." (TNDOE, 2022).

These courses are overseen by three District offices: Optional Schools and Advanced Academics; College, Career, and Technical Education (CCTE); and Curriculum and Instruction. Together they support students, teachers, and school administrators and assist all schools in leveraging and expanding these specialized courses to offer more opportunities for students to earn college credit.

Goal:

 Provide equitable opportunities for students to complete advanced coursework in alignment with <u>Board policy (5005)</u>.

Summary & Key Findings

• Course Offerings 2023–24

- \circ 96% of District-managed schools offered at least 6 AP, virtual AP, or Pre-AP courses.
- o 100% of District-managed schools offered at least 5 dual enrollment or statewide dual credit (SDC) courses.
- $\,\circ\,$ 100% of District-managed schools offered at least 5 honors or Pre-AP courses.
- $_{\odot}$ 94% District-managed schools offered at least 1 local dual credit (LDC) course.

• Participation 2022–23

- A large majority (74%) of the District's high schoolers took at least one advanced course last year.
- DE and honors/Pre-AP participation rates increased by 1 and 4 percentage points, respectively, last year as compared to the year before, while the AP participation rate remained steady.
- However, the SDC participation rate declined by 12 percentage points during the period, likely the result of stricter prerequisites that TNDOE put in place for SDC courses.

Summary & Key Findings

- Participation 2022–23 (Cont.)
 - Last year, a sizeable majority (73%) of economically disadvantaged (ED) high schoolers took at least one advanced course—just 6 percentage points behind their non-ED counterparts.
 - Black/African American, Hispanic/Latino, and Multiracial students had higher participation rates in SDC courses than did Asian and White students, whereas the opposite was true for participation in AP and honors/Pre-AP courses.

• Performance 2022–23

- The percentage of AP exams scoring a 3 or higher last year was 46% in District-managed schools, as compared to just 16% in charter schools.
- 95% of students who were enrolled in a DE course earned college credit by passing the course with a D or higher grade.


Data Notes

- Course Definitions:
 - Advanced Placement: <u>a high school course that offers the same rigor and content as college courses</u>, giving students the opportunity to earn college credit and prepare for college while still in high school. Students <u>may earn college credit by passing an AP exam</u> at the end of the course.
 - Dual Enrollment: a postsecondary course that is taught by a credentialed faculty member (can be a high school teacher who is an adjunct) that accelerates learning in a collegiate environment. High school students are enrolled at the partnering college and have the opportunity to earn college and high school credit simultaneously. Students may earn college and high school credit by passing the course.
 - Statewide Dual Credit: <u>a high school course aligned with a postsecondary challenge examination</u> developed and approved by the Consortium for Cooperative Innovative Education, which <u>allows students exceeding an established cut score to earn postsecondary</u> <u>credit at any public postsecondary institution</u>. This course is taught by high school faculty at the high school that has been approved and trained by the state (TDOE). The state (TDOE) administers the challenge exam and maintains record of student scores/earned credits.
 - Local Dual Credit: <u>a high school course that is aligned with a postsecondary challenge examination at a specific postsecondary</u> <u>institution</u>, which <u>allows students exceeding an established cut score to earn postsecondary credit at that institution</u> (not typically transferrable).



Advanced Coursework: Course Offerings- Advanced Placement District-managed: 100% of traditional high schools offer at least 6 AP, virtual AP, and Pre-AP courses with a minimum of 3 AP or virtual AP.

- 96% (26 out of 27) of Districtmanaged schools offered at least 6 AP, virtual AP, or Pre-AP courses.
- The median AP course count when looking at only Districtmanaged schools was 6.





Advanced Coursework: Course Offerings- Advanced Placement

- 76% (31 out of 40) MSCS high schools (Districtmanaged & charter) offered at least 6 Advanced Placement (AP), virtual AP, or Pre-AP courses.
- The median AP course count was five.
- Schools with zero course offerings: City University, City University School of Independence, Compass Community School Midtown, and KIPP Memphis Collegiate High.




Advanced Coursework: Course Offerings- Dual Enrollment & SDC

District-managed: 100% of traditional high schools have at least 5 SDC or DE courses.



- 27 (100%) District-managed schools offered at least 5 dual enrollment or statewide dual credit courses.
- The median DE/SDC course count when looking at only Districtmanaged schools is
 16. The median SDC course count is 3. The median DE course count is 11.


2023–24 Count of DE & SDC Offered: District-Managed Schools



Advanced Coursework: Course Offerings- Dual Enrollment & SDC

- 80% (32 out of 40) MSCS high schools offered at least 5 dual enrollment (DE) or statewide dual credit (SDC) courses.
- The median DE/SDC course count when including charter schools is 12. The median SDC course count is 3. The median DE course count is 9.
- Schools that had zero course offerings: City University School of Independence, Compass Community Schoo Midtown, Freedom Prep Academy Flagship.




Advanced Coursework: Course Offerings- Local Dual Credit District-managed: 94% of traditional high schools have at least 1 LDC course.



2023–24 Count of LDC Offered: District-Managed Schools

- 100% (all 27) of Districtmanaged schools offered at least 1 local dual credit (LDC) course.
- The median LDC course count was 2.





Advanced Coursework: Course Offerings- Honors & Pre-AP

- When excluding charter schools, all 30 (100%)
 District-managed schools included offered at least 5 honors or Pre-AP courses.
- The median honors/Pre-AP course count was 20.

District-managed: 100% of traditional high schools have a minimum of 5 Honors/Pre-AP courses.





Advanced Coursework: Course Offerings- Honors & Pre-AP

- 88% (38 out of 43)
 of MSCS schools
 offered at least 5
 honors or Pre-AP
 courses.
- The median honors/Pre-AP course count when including charter schools was 17.
- Schools that had zero course offerings: KIPP Memphis Collegiate High.




Advanced Coursework: Course Participation

- The rate of advanced-course participation among District-managed high schoolers last year was high: 75%, which was a 3point increase from the year before.
- DE and honors/Pre-AP participation rates increased by 1 and 4 percentage points, respectively, while the AP participation rate remained steady.
- However, the SDC participation rate declined by 12 percentage points.
 - TNDOE instituted stricter prerequisites for SDC courses, preventing 9th and 10th graders from enrolling in many of those courses.

District-managed: Increase the percentage of students enrolled in advanced courses.





Last year, a large majority (74%) of MSCS's high schoolers participated in advanced coursework, up 4 percentage points from the year before.



Advanced Coursework: Course Participation by Race/Ethnicity


The racial/ethnic makeup of advanced course-takers mirrors that of the District's high schoolers overall.



Advanced Coursework: Course Participation by Race/Ethnicity

- For the past two years, Asian students have had the highest advanced course participation rates, followed by White, Multiracial, Black/African American, and Hispanic/Latino students, respectively.
- Notably, the participation rate for Hispanic/Latino students climbed by 9 percentage points during the period.

Participation in Advanced Courses by Race/Ethnicity: District-Managed Schools



Advanced Coursework: AP Course Participation by Race/Ethnicity

• Asian students took AP courses at much higher rates than other racial/ethnic groups, followed by White students, and trailed by Multiracial, Hispanic/Latino, and Black/African American students.

Participation in AP Courses by Race/Ethnicity: District-Managed Schools





Advanced Coursework: DE Course Participation by Race/Ethnicity

 Asian students also had the highest DE course participation rates for the past two years, followed by Black/African American and Multiracial students, then White students, then Hispanic/Latino students.



Advanced Coursework: SDC Course Participation by Race/Ethnicity

- By contrast, Black/African American students had the highest SDC course participation rates for the past two years, followed by Multiracial and Hispanic/Latino students, and trailed by White students and then Asian students.
- There was a decline in SDC participation rates across all racial/ethnic groups from 2021–22 to 2022–23, likely owing to the stricter prerequisites that TNDOE put in place for SDC courses.



Participation in SDC Courses by Race/Ethnicity: District-Managed Schools

Advanced Coursework: Honors/Pre-AP Course Participation by Race/Ethnicity

- For the past two years, Asian students have had the highest honors/Pre-AP course participation rates, followed by White, Multiracial, Black/African American, and Hispanic/Latino students, respectively.
- Honors/Pre-AP participation rates rose 2–6 percentage points across all racial/ethnic groups from 2021–22 to 2022–23.







Advanced Coursework: Course Participation by Economic Status

- Last year, a sizeable majority (73%) of economically disadvantaged (ED) high schoolers took at least one advanced course—just 6 percentage points behind their non-ED counterparts.
- Though ED students had lower participation rates in AP, DE, and honors/Pre-AP courses than non-ED students, they had higher SDC course participation than their non-ED counterparts.

2022–23 Participation in Advanced Courses by Economic Status: District-Managed Schools



Advanced Coursework: Dual Enrollment Pass Rates District-managed: Achieve a 93% pass rate in DE courses.


- When excluding charter schools, 95% of students who were enrolled in a DE course earned a college credit by passing the course with a D or higher grade.
- The median grade was 91.

Advanced Coursework: Dual Enrollment Pass Rates

- For MSCS Schools (District-managed & charter) 95% of students who were enrolled in a DE course earned a college credit by passing the course with a D or higher grade.
- The median grade when including charter schools was 90.




Dual Enrollment Pass Rate: MSCS Schools (District-Managed & Charter)



Advanced Coursework: AP Exam Performance

District-managed: Increase the % of AP exams with a score of 3 or higher.

- For MSCS as a whole (District-managed & charter schools), the percentage of AP exams with a score of 3 or higher remained the same (37%) last year as compared to the year before.
- District-managed schools improved by 1 percentage point, while charter schools declined by 2 percentage points.
- District-managed schools outperformed charter schools by 30 percentage points last year.




Performance on AP Exams



Advanced Coursework: AP Exam Performance by Economic Status


• The AP exam performance of economically disadvantaged (ED) students and their non-ED counterparts remained the same last year as compared to the year before, with non-ED students outperforming ED students by 23 percentage points in both years.

Advanced Coursework: AP Exam Performance by Race/Ethnicity

- AP exam performance improved for all but one racial/ethnic group from 2021–22 to 2022–23.
- Asian students had the highest performance, followed by White students, then Hispanic/Latino and Multiracial students, and trailed by Black/African American students.

Next Steps:


- Two additional local dual credit courses are proposed for the 2024–25 school year.
 - LDC Lifetime Wellness
 - o LDC U.S. Government
- Continue to expand access and enrollment in Early Postsecondary Opportunities (EPSOs) (AP, IB, DE, SDC).
- Continue to administer the PSAT 8/9 assessment to identify potential students for advanced academics coursework earlier and strengthen the pipeline of students prepared for college-level courses.
- Continue to leverage the <u>SEM Advancement Act</u> to ensure equitable access to advanced courses.
- Continue to provide professional development and specialized training, enabling honors/pre-AP/AP/IB teachers to provide high-quality, research-based, cutting-edge classroom learning experiences for students.
- Continue to utilize AP Virtual Academy and AP Access for All to increase the number of AP courses districtwide.

Advanced Coursework: Statewide Dual Credit Pass Rates

- For MSCS Schools (District-managed & charter) 99% of students who were enrolled in a SDC course passed the course with a D or higher grade.
- The median grade when including charter schools was 88.




Statewide Dual Credit Pass Rate: MSCS Schools (District-Managed & Charter)

- The median grade was 88. ٠




Statewide Dual Credit Pass Rate:

- 97% of students who were enrolled in a LDC course passed the course with a D or higher grade.
- The median grade was 87.
