RE: Addendum #2: IFB#07292020 – **Flashing Traffic Signs for various SCS Locations**

Dear Bidders:

This Addendum forms a part of the Contract Documents and modifies the Plans and Specifications dated July 13, 2020. The Contractor shall acknowledge receipt of this Addendum on the Bid Form. Failure to do so may subject the Bidder to disqualification.

### **Item #1 Replace Snowden Photo**

At Snowden school, the Contractor shall replace the Snowden Addendum #1 aerial PDF photo/notes and replace it with this new Snowden school Addendum #2 aerial PDF photo/notes. This Snowden school Addendum #2 aerial PDF photo/notes replaces page 3 of the Snowden page 3 of the City drawings. The sidewalk previously stated as being installed as part of the base bid on the south side of Tutwiler from McLean to the school's service road as stated in Addendum #1 is not required. Instead the Contractor shall incorporate in his/her base bid the new Addendum #2 aerial photo with stated requirements. Original signage for Snowden as stated in City drawings shall still be required but the exact locations of signage will differ and will be discussed at the pre-construction meeting with the City Traffic Engineering Division. **Item #2**

### **Item # 2 – Remove tree limbs**

At Snowden school, the Contractor shall remove tree limbs along the westbound section of N. Parkway that is currently obscuring the line of sight from the existing pole that is designated as receiving a new flashing sign per Snowden School City bid drawing. Tree limbs shall be removed up to 125' east of the designated pole as necessary to achieve a safe proper line of sight.

### **Item #3 Question and Response**

On the Q&A sheet of Addendum 1, item #12, Question #6 response shall be replaced with the following response: The Contractor shall refer to Addendum #2 aerial PDF photo/notes for sidewalk, curb cut, handicap ramp and crosswalk requirements. There is not an Alternate cost required for Snowden School, the additional sidewalk, curb cut and crosswalks should now be a part of the base bid per above stated Addendum #2 Snowden aerial PDF photo/notes. The requirement of a sidewalk on the south side of Tutwiler from McLean eastward to the school's service road is not required.

**Item #4 Question and Response**

On the Q&A sheet of Addendum 1, item #12, Question #8, the Contractor shall add Craigmont Middle to the response of list of schools needing fencing. Refer to #5 below.

**Item #5 Questions and Response**

Projected start, end dates and liquidated damages– The Contractor shall incorporate in his/her base bid the Addendum #2 aerial photo of the fence requirement at Craigmont Middle School. The Contractor shall field verify all fencing requirements.

**Item #6 Bid Allowance**

The Contractor shall incorporate in his/her base bid an allowance of \$5,000.00 to cover any street/ramp modifications that may be necessary to fulfill Code requirements.

**Item #7 – School Work Dates**

The following are dates that school will not be in session and the students will be out:  
There will be no arrival & dismissal times of students during these dates so the Contractor shall not be required to cease construction work on these dates during arrival and dismissal times.  
9/7/20, 10/12/20 thru 10/16/20, 11/11/20, 11/23/20 thru 11/27/20, 12/21/20 thru 1/1/21, 1/18/21, 2/15/21, 3/29/21 thru 4/2/21 & 5/21/21.
