Item #1

IFB Language Revision –Please see below for language revision for Appendix A, 13.0 Insurance, C.2 SCBE Provided Insurance. Please replace the original language with the revised language,

Original Language

"SCBE shall purchase builder's risk insurance coverage for all contractors and sub-contractors at all tiers, but only with respect to covered operations performed on behalf of SCBE at the specified project site. Limits and aggregates are not per project and therefore any uninsured loss due to aggregate or limit exhaustion is at Contractor's risk. Deductible: \$25,000 each and every occurrence."

Revised Language

"Contractors and sub-contractors shall be responsible for purchasing builder's risk insurance coverage at all tiers under this project".

- 2. Awarded contractor will be responsible for all hazardous abatement in the middle and high school building. See the following attachments. Though all hazardous material reports have been included, contractor will only be responsible for hazardous material abatement in the middle and high school building.
- 3. Refer to Spec Section 01 02 00 Allowances. Revise controls allowances per attached.
- 4. Ceiling Type Clarifications
 - a. Ceiling Type for Servery to be Type D: New 24" x 24" Acoustical Tile & Grid Type B (Kitchen) Armstrong Georgian High Washability Unperforated 793 with 15/16" Prelude Grid.
 - b. Ceiling Type for Kitchen Spaces to be Type G: New Gyp. Bd. Ceiling/Furrdown Paint Color G (White) Horizontal and Vertical Surfaces unless otherwise noted.
 - c. Note ceiling in kitchen to be moisture resistant gyp board.
 - d. Paint (kitchen areas):

One coat:

- a. PPG 16-90 Pitt-Glaze Block Acrylic Filler VOC 51.8% Volume Solids (138 g/L VOC)
- b. Benjamin Moore V155 100% Solids Epoxy Pre-Primer 98% Volume Solids (6 g/L VOC)
- c. Devran Tru-Glaze-WB 4015 Water Borne Epoxy Block Filler 53% Volume Solids (99 g/L VOC)

Two coats:

- a. PPG Amercoat Amerlock 2 VOC Semi-Gloss 83% Volume Solids (84.0 g/L VOC)
- b. Benjamin Moore V160 Epoxy Coating 79% Volume Solids (184 g/L VOC)
- c. Devran 224V Two-Component Epoxy Semi-Gloss 77% Volume Solids (28 g/L VOC)

Item #5 - MODIFICATIONS/CLARIFICATIONS TO THE MECHANICAL DRAWINGS

1. Refer to the drawings, Sheet M1.12. The SAD-1 devices in the kitchen should be as follows:

Supply Air Diffuser. 24"x 24" perforated face ceiling return grilles used for supply air delivery in the kitchen so that airflow from supply diffusers does not disrupt kitchen hood capture performance. 24"x 24" perforated face with flat surface mounting frame and 18"x18" square neck. Insulated back pan to prevent sweating.
